A sign needs to be re-installed and has been reported via the "report it" website by Cotswold Volunteers. It was also discussed if a gate could be put up which would effectively block a right of way. It was stated by CVW that it would be illegal to install a gate and the restricted by-way must be accessible (by horse & cart). It was stated that the "Dowmans residents" own this part of right of way. CVW has liaised with the PROW's manager and looked at legislation that would enable a gate to be installed and it was not felt at this time that this would be
